- (3) Phantom stock units will be converted to cash beginning at retirement; my retirement date is unknown.
- (4) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 3,690.4943 units in such plan in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
