- (1) Restricted Stock Units granted under the BlackRock, Inc. 1999 Stock Award and Incentive Plan (the "Incentive Plan") as part of the reporting person's bonus approved by the Management Development and Compensation Committee of the Board of Directors for the 2009 fiscal year under the Amended and Restated 1999 Annual Incentive Performance Plan. The number of Restricted Stock Units was determined by dividing the approved dollar value of the equity award by \$218.735, which was the average of the high and low price per share of Common Stock on January 29, 2010. This formula was approved by the Management Development and Compensation Committee on January 19, 2010. Each Restricted Stock Unit is payable solely by delivery of an equal number of shares of Common Stock and vests in installments on 1/31/11, 1/31/12 and 1/31/13.
- (2) Includes (i) 199 Restricted Stock Units granted under the Incentive Plan vesting on 1/31/11, (ii) 602 Restricted Stock Units vesting in equal installments on 1/31/11 and 1/31/12 and (iii) 485 Restricted Stock Units vesting in installments on 1/31/11, 1/31/12 and 1/31/13. Each Restricted Stock Unit is payable solely by delivery of an equal number of shares of Common Stock.
- (3) Additional shares of Restricted Stock Units granted under the Incentive Plan and approved by the Management Development and Compensation Committee of the Board of Directors. The number of Restricted Stock Units was determined by dividing the approved dollar value of the equity award by \$218.735, which was the average of the high and low price per share of Common Stock on January 29, 2010. This formula was approved by the Management Development and Compensation Committee on January 19, 2010. Each Restricted Stock Unit is payable solely by delivery of an equal number of shares of Common Stock and vests on 1/31/12.
- (4) Includes (i) 199 Restricted Stock Units granted under the Incentive Plan vesting on 1/31/11, (ii) 602 Restricted Stock Units vesting in equal installments on 1/31/11 and 1/31/12, (iii) 485 Restricted Stock Units vesting in installments on 1/31/11, 1/31/12 and 1/31/13 and (iv) 1,942 Restricted Stock Units vesting on 1/31/12. Each Restricted Stock Unit is payable solely by delivery of an equal number of shares of Common Stock.
- (5) Represents the withholding by BlackRock of Restricted Stock Units to satisfy tax obligation on the vesting of the reporting person's Restricted Stock Units granted under the Incentive Plan.
