- (1) Holdings, Inc. and Buccaneer Merger Sub, Inc., dated as of October 28, 2010 (the "Merger Agreement"), in exchange for a cash payment in the amount of \$31.00 per share.
- (2) The options, whether vested or unvested, were cancelled pursuant to the Merger Agreement in exchange for a cash payment in the amount of \$31.00 per share less the exercise price of the option.
- (3) The options vested in three equal annual installments on each of August 15, 2008, August 15, 2009 and August 15, 2010.
- (4) The options vest in three equal annual installments on each of August 15, 2009, August 15, 2010 and August 15, 2011.
- (5) The options vest in three equal annual installments on each of August 10, 2010, August 10, 2011 and August 10, 2012.
- (6) The options vest in three equal annual installments on each of February 17, 2011, February 17, 2012 and February 17, 2013.
- (7) The options vest in three equal annual installments on each of August 5, 2011, August 5, 2012 and August 5, 2013.
