- (1) The sales reported in this Form 4 were effected pursuant to a pre-arranged trading plan established in accordance with Rule 10b5-1 of the Securities Act of 1934, as amended.
- (2) Represents shares of performance based restricted stock units granted to the filing person on January 11, 2011. The vesting of the shares of performance based restricted stock units was conditioned upon the achievement of certain 2011 earnings before interest, taxes, depreciation, and amortization ("EBITDA") performance versus pre-established targets. The restricted stock units vest over three years (1/3 on February 08, 2012; 1/3 on January 2, 2013; and 1/3 on January 2, 2014). Of the 16,994 shares of common stock, 5,664 shares were issued on February 08, 2012, of which 2,405 shares were withheld to satisfy payment of the Issuer's tax withholding obligation. The remaining 11,330 shares are scheduled to be issued on the two remaining vesting dates and taxes for these future issuances will be
