 - (2) Each restricted stock unit represents a contingent right to receive one share of RealNetwork common stock.

The restricted stock units will vest in 12 substantially equal monthly installments until the restricted stock units become fully vested on

- (3) the first anniversary of the date of grant, provided that the reporting individual continues to serve as a director of RealNetworks through such date. The share distribution date applicable to the restricted stock units is the sooner to occur of (1) the first anniversary of the date of grant or (2) the date of separation from the Board.
