  - (3) The dividend equivalent rights and related RSUs vest in full on December 31, 2016 and may vest in full upon a change of control (as defined in the Aviv REIT, Inc. 2013 Long-Term Incentive Plan), subject in each case to the holder not incurring a termination through the vesting date.
  - (4) Reflects corrected RSU amount. No other changes have been made to the Form 4 originally filed on July 15, 2014.
