- (1) The weighted average sale price reflects multiple transactions at prices ranging from \$73.25 - \$73.40.
 - (2) Effective October 24, 2014, the Board of Directors accelerated the vesting of all the outstanding stock options, and all outstanding stock options are now fully vested.

Performance stock rights represent the right to receive shares of common stock of the Company, in the event certain performance goals are satisfied.
