- In connection with the closing of the transactions contemplated by the Contribution Agreement dated as of December 2, 2014, by and between the Issuer and PBF Energy Company LLC ("PBF LLC"), PBF LLC contributed to the Issuer all of the equity interests of Toledo Terminaling Company LLC, for total consideration payable to PBF LLC of \$150 million, consisting of \$135 million of cash and 620,935 common units of the Issuer.
- (1) PBF Energy Inc. is the sole managing member of PBF LLC and operates and controls all of PBF LLC's business and affairs and consolidates the financial results of PBF LLC and its subsidiaries. PBF Energy Inc. also indirectly owns a non-economic general partner interest in the Issuer through PBF Logistics GP LLC, a wholly owned subsidiary of PBF LLC.
