  - (3) Represents the proportionate interest of the Reporting Person in 2,332,878 common units of the Partnership issued and sold to StoneMor GP Holdings LLC ("GP Holdings") by the Partnership, which purchase was funded by the purchase of common units of GP Holdings by a trust for the pecuniary benefit of American Cemeteries Infrastructure Investors, LLC.
  - (4) The Reporting Person is a member of GP Holdings.
  - (5) The Reporting Person disclaims beneficial ownership of the common units except to the extent of his pecuniary interest therein.
  - (6) These common units are held in a trust for the benefit of the Reporting Person's child. The Reporting Person's spouse is trustee of the trust.
