The restrictions on these restricted stock units shall lapse 100% on the third anniversary of the grant date if the Company's cumulative diluted earnings per share growth during the 36 month period ending on the last day of the Company's fiscal year 2011 equals or exceeds a 5% compound annual growth rate, as determined by the Compensation Committee.

(3) These options become exercisable at the rate of 25% of the shares granted per year beginning on the first anniversary of grant.
