- (1) Between August 4, 2005 and November 7, 2005, the Reporting Person acquired 40 shares of Duke Realty Corporation common stock through dividend reinvestment.
 - (2) Between August 4, 2005 and November 7, 2005, the Reporting Person acquired 109 shares of Duke Realty Corporation common stock under the Company's 401(k) plan.
 - (3) Units of Duke Realty Limited Partnership are convertible on a one to one basis to the Company's common stock and have no expiration date.
 - (4) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/28/03.
 - (5) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/26/04.
 - (6) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/31/06.
 - (7) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/30/07.
 - (8) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 2/19/08.
 - (9) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 7/30/08.
 - (10) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/28/09.
