The reported transactions involved an amendment of an outstanding option, resulting in the deemed cancellation of the old option and the grant of a replacement option. The old option was originally granted on November 19, 2003 and provides for 12/48th of the shares (1) exercisable on November 19, 2004, with the remainder becoming exercisable in equal monthly installments over the next three years. The new option is granted at an exercise price of \$3.35 per share and provides for 1/36th of the shares vesting on April 16, 2007 and each one-month thereafter for so long as the reporting person remains a service provider of the Company.
