## Explanation of Responses:

- (1) Pursuant to a merger between issuer and McKesson Corporation, each service based RSU (5,041 issuer shares in total) was assumed by McKesson and replaced with McKesson common stock in an amount equal to the number of underlying issuer common shares multiplied by .50053629 (the ratio of \$28 to \$55.94, the closing price of McKesson stock on the date of closing). Performance RSUs were doubled on the day of the merger for meeting a performance goal and pursuant to the merger, each performance based RSU was cancelled in exchange for \$28 cash for each share of issuer common stock underlying the RSU (20,470 issuer shares in total). The remaining 6,622 shares of issuer stock was disposed of in exchange for \$28 cash.
- (2) Pursuant to a merger between the issuer and McKesson Corporation, each option was cancelled in exchange for cash equal to \$28 less the exercise price multiplied by the number of shares subject to each option grant.
