- This Form 4 reports the purchase, by Dr. Armen, of 100,000 shares of Agenus Inc. common stock. Of the 100,000 shares purchased by Dr. Armen and reported herein, 19,576 shares were matchable under Section 16(b) of the Securities Exchange Act of 1934 with Dr. Armen's sale of an equivalent number of shares of Agenus common stock at a weighted average price of \$4.5715 per share on December 29, 2015. Dr. Armen has paid to Agenus, as of May 9, 2016, \$27,714.24, representing the full amount of the profit realized in connection with the short-swing transaction.
