On November 16, 2015, RenaissanceRe Holdings Ltd. issued a press release announcing that James L. Gibbons, who has been a member of the Board since 2008 and Chair of the Audit Committee since 2013, will become the Non-Executive Chair of the Board of Directors following the Company's Annual General Meeting of Shareholders in May 2016.
