Item 8.01 Other Events.

On December 12, 2008, International Coal Group, Inc. (the “Company”) issued a press release announcing that its Wolf Run Mining Company subsidiary will permanently close its idled Sago mine in Buckhannon, West Virginia. Although the equipment assets are expected to be recovered prior to mine closure, the Company anticipates recording a fourth quarter non-cash asset impairment charge of approximately \$7.2 million related to non-recoverable mine development costs. The Company expects to permanently close and seal the mine in the first quarter of 2009. A copy of the Company’s press release is attached hereto as Exhibit 99.1.
