- (1) ON APRIL 8, 2008, THE REPORTING PERSON RECEIVED A SPECIAL EQUITY GRANT OF 74,000 SHARES OF RESTRICTED STOCK PURSUANT TO THE IDEX CORPORATION INCENTIVE AWARD PLAN (AS AMENDED AND RESTATED), OF WHICH APPROXIMATELY 16.67% WILL VEST ON APRIL 8, 2009, APPROXIMATELY 16.67% WILL VEST ON APRIL 8, 2010 AND THE REMAINING 66.66% WILL VEST ON APRIL 8, 2011.
- (2) THE OPTION GRANT VESTS IN FOUR EQUAL INSTALLMENTS BEGINNING ON APRIL 8, 2009.
- (3) ON MAY 21, 2007, THE COMPANY STOCK OF IDEX CORPORATION SPLIT 3 FOR 2, RESULTING IN THE REPORTING PERSON'S ACQUISITION OF 77,090 ADDITIONAL OPTIONS.
