If not converted sooner, the shares of Series G Preferred would mandatorily convert at the then-current exchange rate in the event of a qualified public offering or upon the vote of holders of a majority of the stated value of the Series G Preferred issued and outstanding, and will be will be mandatorily redeemed by conversion to common stock at the then-current exchange rate at the two year anniversary of the final sale under the offering, which is anticipated to be April 1, 2016.
