- (1) Mr. McDonald was awarded 63,362 restricted stock units on June 25, 2012. The restrictions lapsed on the remaining units (21,121 shares) and Mr. McDonald elected to have Hecla Mining Company withhold 9,673 shares to cover his tax liability.
- (2) Mr. McDonald was awarded 90,909 restricted stock units on June 25, 2014. The restrictions lapsed on one-third of those stock units (30,303 shares) and Mr. McDonald elected to have Hecla Mining Company withhold 13,879 shares to cover his tax liability.
