(1) On March 31, 2004, Mr. Brewster was granted 357,682 options with a strike price of \$6.54. These options vested over a four year period and thus became 100% vested as of March 31, 2008.

(2) On March 6, 2006, Mr. Brewster was granted 119,227 options with a strike price of \$10.55 per share. The options vested over a four year period and therefore all of these options became fully vested as of March 6, 2010.
