The value of the SMCA is payable in cash following the reporting person's termination of employment with the Issuer and its subsidiaries.
- (6) Options to buy 5,264 shares become exercisable on 02/15/2012 and options to buy 5,263 shares become exercisable on each of 02/15/2013 and 02/15/2014.
