The reported shares are represented by restricted stock units or RSUs, which will vest upon the satisfaction of both a service condition and a liquidity-event condition. The liquidity-event condition will be satisfied on the earlier of (i) six months after the effective date of the initial public offering of the Issuer's common stock pursuant to an effective registration statement, or (ii) March 15 of the calendar year following the year in which the initial public offering was declared effective; and (iii) the time immediately prior to the consummation of a change in control. After satisfaction of the liquidity-event condition, 25% of the total number of shares of common stock underlying the RSUs will vest on October 24, 2014 and the remaining balance will vest in equal annual installments over the following three years.

(2) Of the reported shares, 383,973 shares are represented by RSUs.
