The amount beneficially owned by the reporting person includes: (i) 24,202 shares of Class A common stock and restricted stock units that will convert into 5,000 shares of Class A common stock within 60 days, (ii) 12,875,346 shares of Class B common stock, and (iii) 344,000 shares of Class A common stock held by the Conine Family Foundation, of which the reporting person's spouse is President.

Each share of Class B common stock is convertible at any time at the option of the Reporting Person into one share of Class A common stock. In addition, each share of Class B common stock will automatically convert into one share of Class A common stock (a) upon transfer thereof, subject to certain exceptions, (b) upon the date on which the outstanding shares of

Class B common stock represent less than 10% of the aggregate number of shares of the then outstanding Class A common stock and Class B common stock, or (c) in the event that holders of at least 66<sup>2/3</sup>% of the then outstanding shares of Class B common stock elect to convert all shares of Class B common stock into shares of Class A common stock.

The ownership percentage above is based on an aggregate of 70,279,329 shares of Class A common stock outstanding, consisting of (i) 57,398,983 shares of Class A common stock outstanding as of December 31, 2017, and (ii) 12,880,346 shares of Class A common stock issuable upon conversion on a one-for-one basis of 12,880,346 shares of Class B common stock owned by the reporting person or issuable to the Reporting Person within 60 days after December 31, 2017.
