21,750,058 of the shares of Class A Common Stock of FIRST DATA CORP reported as being beneficially owned by the reporting persons at October 30, 2015, are included in this Schedule 13G because the reporting persons may be deemed to beneficially own such shares as a result of the direct ownership of 21,750,058 shares of Class B Common Stock of FIRST DATA CORP by investment companies and institutional accounts advised by Fidelity Management & Research Company and Pyramis Global Advisors, LLC, both of which are wholly-owned subsidiaries of FMR LLC, which shares of Class B Common Stock are convertible into shares of Class A Common Stock at the election of the holder, subject to the consent of FIRST DATA CORP, at an exchange rate of 1:1. Assuming the conversion of all outstanding shares of Class B Common Stock into Class A Common Stock, the 33,986,343 shares of Class A Common Stock reported as being beneficially owned by the reporting persons in this Schedule 13G would represent 3.80% of the outstanding Class A Common Stock.

21,750,058 of the shares of Class A Common Stock of FIRST DATA CORP reported as being beneficially owned by the reporting persons at October 30, 2015, are included in this Schedule 13G because the reporting persons may be deemed to beneficially own such shares as a result of the direct ownership of 21,750,058 shares of Class B Common Stock of FIRST DATA CORP by investment companies and institutional accounts advised by Fidelity Management & Research Company and Pyramis Global Advisors, LLC, both of which are wholly-owned subsidiaries of FMR LLC, which shares of Class B Common Stock are convertible into shares of Class A Common Stock at the election of the holder, subject to the consent of FIRST DATA CORP, at an exchange rate of 1:1. Assuming the conversion of all outstanding shares of Class B Common Stock into Class A Common Stock, the 33,986,343 shares of Class A Common Stock reported as being beneficially owned by the reporting persons in this Schedule 13G would represent 3.80% of the outstanding Class A Common Stock.

Edward C. Johnson 3d is a Director and the Chairman of FMR LLC and Abigail P. Johnson is a Director, the Vice Chairman, the Chief Executive Officer and the President of FMR LLC.

Members of the family of Edward C. Johnson 3d, including Abigail P. Johnson, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d nor Abigail P. Johnson has the sole power to vote or direct the voting of the shares owned directly by the various investment companies registered under the Investment Company Act ("Fidelity Funds") advised by Fidelity Management & Research Company ("FMR Co"), a wholly owned subsidiary of FMR LLC, which power resides with the Fidelity Funds' Boards of Trustees. Fidelity Management & Research Company carries out the voting of the shares under

written guidelines established by the Fidelity Funds' Boards of Trustees.

This filing does not reflect securities, if any, beneficially owned by certain other companies whose beneficial ownership of securities is disaggregated from that of the FMR Reporters in accordance with Securities and Exchange Commission Release No. 34-39538 (January 12, 1998).
