- (10) Phantom Stock Units held for the benefit of reporting person as of September 30, 2012 based on the value of Humana common stock on a 1-for-1 basis, under the Humana Excess Plan. 1 share was acquired for a quarterly allocation of dividends under the Plan using the closing price of the dividend payable date on July 27, 2012.
