On February 13, 2014, the reporting person exercised 10,000 stock options, delivered 3,757 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 2,345 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding.
