## Explanation of Responses:

- (1) This Form 4 is being amended to report the number of options granted, which was unknown at the time of the original filing on 3/5/2013, pursuant to a formula approved by the Compensation Committee.  

The number is calculated as a function of base pay, a long-term incentive (LTI) percentage and the fair value of the option. The Binomial
- (2) Lattice option valuation model will be used to estimate the fair value of the option. This model requires the input of certain assumptions, including risk-free interest rate, volatility, dividend yield, and expected life. The formula for determining the number of options granted is:  $\text{number of options} = (\text{base pay} \times \text{LTI}\%) / \text{option fair value}$ .
- (3) Granted under the issuer's 2010 Equity Incentive Plan, exercisable in four equal annual installments commencing on 3/4/2013
