With respect to the preferred shares of the Issuer owned by WFBNA (the "Preferred Shares"), on September 12, 2016, WFBNA assigned certain preferred class voting rights on the Preferred Shares to a voting trust (the "Voting Trust") created pursuant to the Voting Trust Agreement, dated September 12, 2016 among WFBNA, Lord Securities Corporation, as voting trustee (the "Voting Trustee") and Institutional Shareholder Services Inc. (the "Voting Consultant"). Voting and consent rights on the Preferred Shares not assigned to the Voting Trust have been retained by WFBNA. The Voting Trust provides that with respect to voting or consent matters relating to the voting rights assigned to the Voting Trust, the Voting Consultant analyzes such voting or consent matters and makes a recommendation to the Voting Trustee on voting or consenting. The Voting Trustee is obligated to follow any such
