- (1) On January 10, 2007, the closing price of Issuer's common stock on the NYSE was \$6.96. No consideration was paid by the Reporting Person in connection with this common stock.

- (3) Of such amount, 322 shares are held indirectly by Reporting Person in his 401(k).
