Mr. Dobbin is Chairman of the Board of SII. As of October 14, 2014, SII owns 5.68% of the outstanding common stock of Good Times Restaurants Inc. Mr. Dobbin disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein. Mr. Dobbin has 12,667 shares of underlying presently exercisable stock options.
