FM Services Company (FM Services), a wholly owned subsidiary of Freeport-McMoRan Copper & Gold Inc. (FCX) entered into a supplemental consulting agreement with J. Bennett Johnston, Jr. This supplemental agreement renews the consulting agreement previously entered into with Mr. Johnston for an additional one-year period beginning January 1, 2009, and ending December 31, 2009. All terms and conditions of Mr. Johnston's original consulting agreement remain unchanged. Mr. Johnston is a director of FCX.

All terms and conditions of Judge McDonald's original consulting agreement remain unchanged. Judge McDonald is a director of FCX.
