Class A Common Stock, \$0.01 par value (Class A Stock). Alan H. Cohen is the record owner of shares of the Issuer's Class B Common Stock, \$0.01 par value (Class B Stock), which are not registered under Section 12 of the Securities Exchange Act of 1934, as amended (the Act), but which are immediately convertible into an equal number of shares of Class A Stock. The Issuer's Class A Stock is registered under Section 12 of the Act.

Item 4. Ownership.

(a) Amount Beneficially Owned:

Alan H. Cohen directly owns 1,459,800 shares of Class B Stock. As the trustee of the Alan H. Cohen Declaration of Grantor Retained Annuity Trust No. 5 (dated 9/10/02) (the "GRAT"), Mr. Cohen may be deemed to beneficially own the 257,413 shares of Class B Stock held by the GRAT. In addition, since Mr. Cohen is the trustee of the

Alan H. Cohen and Linda Marie Cohen Irrevocable Trust UA, dated June 23, 1993 (the "Trust"), which holds 324,484 shares of Class A Stock and 38,850 shares of Class B Stock, he may be deemed to beneficially own the shares of Class A Stock and Class B Stock owned by the Trust. In that case, Mr. Cohen would be deemed to beneficially own 1,756,063 shares of Class B Stock. Additionally, Mr. Cohen may be deemed to beneficially own 53,850 shares of Class A Stock which were gifted by Mr. Cohen to a private charitable foundation (the "Gifted Shares"), and with respect to which Mr. Cohen retains voting and investment power. In that case, Mr. Cohen would be deemed to beneficially own an aggregate of 378,334 shares of Class A Stock.

(b) Percent of Class:

If the shares of Class B Stock beneficially owned by Mr. Cohen were converted into Class A Stock, together with shares of Class A Stock held by the GRAT and the Trust, and together with the Gifted Shares, Mr. Cohen would own approximately 10.4% of the outstanding shares of Class A Stock.

(c) Voting and Dispositive Power:

- (i) Sole power to vote or to direct the vote: 2,134,397
- (ii) Shared power to vote or to direct the vote: 0
- (iii) Sole power to dispose or to direct the disposition of: 2,134,397
