Mr. Cohen controls each of SAC Capital Advisors, SAC Capital Management and Sigma Management. By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors, SAC Capital Management and Mr. Cohen may be deemed to own beneficially 1,172,173 Shares (constituting approximately 4.1% of the Shares outstanding) and (ii) Sigma Management and Mr. Cohen may be deemed to own beneficially 300,000 Shares (constituting approximately 1.1% of the Shares outstanding).
