PSource and the Fund are managed by Laurus Capital  $\mbox{Management},\mbox{ LLC. Valens US and VOFF SPV}$ II are managed by Valens Capital Management, LLC. Eugene Grin and David Grin, through other entities, are the controlling principals of Laurus Capital Management, LLC and Valens Capital Management, LLC and share sole voting and investment power over the securities owned by the Fund and the Investors reported in this Schedule 13G.
