(a) and (b) Peter McCausland beneficially owned an aggregate of 10,892,523 shares of the issuer's Common Stock, or approximately 14.9% of the shares outstanding, as of December 31, 2002, of which 1,202,000 shares were issuable upon exercise of employee stock options.

(c) Peter McCausland had sole power to vote or to direct the vote, and sole power to dispose or to direct the disposition of, 858,185 shares of the issuer's Common Stock, of which 803,736 shares were issuable upon exercise of employee stock options. Mr. McCausland had shared power to vote or to direct the vote, and/or shared power to dispose or to direct the disposition of, 10,034,338 shares of the Common Stock, which included 398,264 shares issuable upon exercise of stock options held by a trust for Mr. McCausland's children, and 13,009 shares held by a charitable foundation (the "Foundation") of which Mr. McCausland is an officer and director.
