### Item 4. Purpose Of The Transaction

Item 4 of the Schedule 13D is amended and restated in its entirety as follows:

As previously disclosed by the Company, on July 31, 2007, American Residential Communities LLC (formerly named American Riverside Communities LLC) (the Buyer), an affiliate of FCP, consummated the transaction (the Transaction) contemplated by the Transaction Agreement (the Transaction Agreement), dated as of April 17, 2007, with the Company and certain of its subsidiaries (collectively, the Sellers) pursuant to which, subject to the terms and conditions thereof and certain exceptions described therein, the Buyer or its subsidiaries purchased all of the Sellers' assets primarily related to, and assumed all of the Sellers' liabilities (other than liabilities for indebtedness and certain other specified excluded liabilities) to the extent related to, the businesses conducted by the Company and its subsidiaries, including the owning and operating of manufactured homes communities, the provision of related financing services and businesses related thereto, but excluding the insurance business of NLASCO, Inc. and related insurance activities.

Upon consummation of the Transaction, the Support Agreement, dated as of April 17, 2007 (the Support Agreement), between the Buyer and each of Gerald J. Ford, ARC Diamond, LP, a Texas limited partnership, and Hunter's Glen/Ford, Ltd., a Texas limited partnership (collectively, the Ford Stockholders), pursuant to which each Ford Stockholder had, among other provisions and subject to certain terms and conditions, agreed to vote its Shares in favor of the Transaction, terminated in accordance with its terms. To the extent that the Reporting Persons may have been deemed to have become members of a group with the Ford Stockholders by virtue of the Support Agreement, any such group was terminated with the termination of the Support Agreement.

Also, as previously disclosed by the Company, on July 16, 2007, pursuant to the terms of the Support Agreement, dated as of April 17, 2007 (the Notes Support Agreement), between the Farallon Funds or their affiliates and Affordable Residential Communities, LP (the Operating Partnership), relating to the 7 1/2% Senior Exchangeable Notes due August 15, 2025 (the Notes) of the Operating Partnership, certain of the Farallon Funds or their affiliates and certain other holders of the Notes granted a waiver to the Operating Partnership, pursuant to which such Note holders waived compliance with (i) Article 6 (Consolidation, Merger, Conveyance, Transfer or Lease) of the indenture relating to the Notes (the "Indenture") and (ii) any default, event of default or other non-compliance under the Indenture, each with respect to the consummation of transactions contemplated under the Transaction Agreement. In connection with the consummation of the Transaction, the Notes Support Agreement terminated in accordance with its terms. The Notes remain outstanding following consummation of the Transaction.

Although no Reporting Person has any specific plan or proposal to acquire or dispose of Shares, consistent with its investment purpose, each Reporting Person at any time and from time to time may acquire additional Shares or dispose of any or all of its Shares depending upon an ongoing
