#### Item 5: Other Events

On July 2, 2002, the Company entered into a Series 2002-1 Supplement to the Amended and Restated Pooling and Servicing Agreement, dated as of April 28, 2000, as amended (the "Agreement"). The Agreement defines the rights of the holders of both the \$750,000,000 Class A Asset Backed Certificates, Series 2002-1 and the \$250,000,000 Class B Asset Backed Certificates, Series 2002-1, issued by the Target Credit Card Master Trust.

The Monthly Servicer's Certificates for the Monthly Period ended July 6, 2002 and the Monthly Certificateholders' Statements for the Monthly Period ended July 6, 2002, with respect to the Class A Asset Backed Certificates, 6.25% Series 1997-1, the Class B Asset Backed Certificates, Series 1997-1, the Class A Asset Backed Certificates, 5.90% Series 1998-1, the Class B Asset Backed Certificates, Series 1998-1, the Floating Rate Class A Asset Backed Certificates, Series 2001-1, the Class B Asset Backed Certificates, Series 2001-1, the Floating Rate Class A Asset Backed Certificates, Series 2002-1, and the Class B Asset Backed Certificates, Series 2002-1, issued by the Target Credit Card Master Trust, were delivered to the Trustee on July 22, 2002, and the Monthly Certificateholders' Statements were then distributed to Certificateholders on July 25, 2002.

The Underwriting Agreement and the related Series 2002-1 Supplement to the Amended and Restated Pooling and Servicing Agreement are filed as Exhibits 1.1 and 4.1 to this report, respectively. The above described Monthly Servicer's Certificates are filed as Exhibits 20.1, 20.3, 20.5, and 20.7 to this Report. The above described Monthly Certificateholders' Statements are filed as Exhibits 20.2, 20.4, 20.6, and 20.8 to this Report.
