- (1) Reflects the sale of shares to satisfy tax payment for vested shares of Restricted Stock under the Company's 2005 Omnibus Incentive Compensation Plan. Also reflects dividends earned on Restricted Stock Awards and reinvested in additional Restricted Stock on June 20 and September 20, 2008, under the Company's 2007 Omnibus Incentive Compensation Plan.
  - (2) The option vests in four equal annual installments beginning on December 13, 2002.
