DTE Energy Company (“DTE Energy”) will meet with investors at the Barclays Energy Conference on September 3-4, 2014. DTE Energy President and Chief Operating Officer Steven Kurmas will provide a business update at the conference at 1:45 p.m. EDT September 4, 2014. In those meetings and in the slide presentation furnished herewith, DTE Energy reaffirms its 2014 operating earnings per share guidance of \$4.20-4.40 per share.

In the slide presentation and this filing, DTE Energy discusses 2014 operating earnings guidance. It is likely that certain items that impact the company's 2014 reported results will be excluded from operating results. Reconciliations to the comparable 2014 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
