Alliance One International, Inc. (the Company) today announced that it will move forward the implementation of the succession plan formulated at the time of its merger. Reflecting the successful completion of the merger integration process, Brian J. Harker, Chairman and Chief Executive Officer, will retire as Chief Executive Officer of the Corporation effective December 31, 2006. The Board of Directors also confirmed the appointment of Robert E.

Pete Harrison, currently President and Chief Operating Officer, to succeed Mr. Harker as Chief Executive Officer as of January 1, 2007. Mr. Harker will continue to serve as Chairman of the Board until the Company's annual meeting in August 2007.
