The 12,747 shares of Common Stock underlying this restricted stock unit award vest in ratable installments on January 1 of each of the first, second, third, fourth and fifth calendar years following the grant date. The restricted stock unit award is subject to payment within 75 days following the applicable vesting date. Each unit represents a right to receive one share of Common Stock or an amount equal to the market value of the Common Stock underlying the award on the applicable vesting date. Payment may be made in cash, shares of Common Stock or a combination thereof.
- (2) This restricted stock unit award pursuant to the Greenhill & Co., Inc. Equity Incentive Plan. The 31,122 shares underlying this restricted stock unit award vest in full on January 1 of the fifth calendar year following the grant date and is subject to payment within 75 days following such vesting date.
