Pursuant to the resolution adopted by the Annual General Shareholders Meeting of TELEFÓNICA, S.A., at its meeting held on May 18<sup>th</sup>, 2011, we hereby inform all shareholders that on November 7<sup>th</sup>, 2011, the Company will pay a dividend to be charged to Unrestricted Reserves, of a fixed gross amount of 0.77 euro for each Company share issued, in circulation and carrying entitlement to this dividend.
