(a) Amount Beneficially Owned

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company (Integrated Core Strategies) may be deemed to be the beneficial owner of 1,683,600 shares of Common Stock. Integrated Core Strategies also holds 2,329,600 warrants of the Company (Warrants). Each Warrant entitles the holder to purchase one share of the Company s Common Stock at a price of \$7.50. Each Warrant will become exercisable on the later of the Company s completion of a business combination and fifteen months from November 14, 2009, and will expire on November 14, 2014, or earlier upon redemption. In certain cases, the Warrants and Common Stock are part of the Company s units.

Millennium Management LLC, a Delaware limited liability company (Millennium Management) is the general partner of Integrated Holding Group LP, a Delaware limited partnership (Integrated Holding Group), which is the managing member of Integrated Core Strategies and consequently may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander (Mr. Englander) is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management, Integrated Holding Group or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.
