The foregoing figures have been provided by Accelrys and are accurate as of February 12, 2014, the most recent practicable date.

This Amendment No. 8 to the Tender Offer Statement on Schedule TO (this “Amendment”) is filed by (i) 3DS Acquisition Corp., a Delaware corporation (“Purchaser”) and a wholly owned direct subsidiary of Dassault Systemes Americas Corp., a Delaware corporation (“Parent”) and a wholly owned indirect subsidiary of Dassault Systèmes SA, a French corporation with limited liability (“Dassault Systèmes SA”); (ii) Parent and (iii) Dassault Systèmes SA. This Amendment amends and supplements the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on February 13, 2014 (together with any amendments and supplements thereto, the “Schedule TO”), and relates to the offer by Purchaser to purchase all of the issued and outstanding shares of common stock, par value \$0.0001 per share (“Shares”), of Accelrys, Inc. (“Accelrys”), a Delaware corporation, at a price of \$12.50 per Share, net to the seller in cash, without interest and subject to any required withholding of taxes, upon the terms and subject to the conditions set forth in the Offer to Purchase dated February 13, 2014 (together with any amendments and supplements thereto, the “Offer to Purchase”), and in the related Letter of Transmittal.

Capitalized terms used and not defined herein shall have the meanings assigned to such terms in the Offer to Purchase.

Items 1 through 9 and Item 11.

Items 1 through 9 and Item 11 of the Schedule TO are hereby amended and supplemented by adding the following text thereto:

“On March 13, 2014, the parties agreed that, notwithstanding anything to the contrary in the Merger Agreement or the Offer to Purchase, the Offer would be extended until 12:00 midnight, New York City time, at the end of the day on Tuesday, March 25, 2014, unless further extended in accordance with the Merger Agreement. The extension allows for the conclusion of the initial 30-day review period by CFIUS, which is scheduled to end no later than Monday, March 24, 2014. By that date, CFIUS is required to have determined whether to conclude its review or undertake an additional 45-calendar day investigation. On March 14, 2014, Dassault Systèmes SA issued a press release announcing the extension of the Offer as described above.

The Depository has advised that as of midnight on March 13, 2014, approximately 40,845,725 Shares had been validly tendered and not validly withdrawn pursuant to the Offer, representing approximately 73.2 percent of the currently issued and outstanding Shares. In addition, as of such time, Notices of Guaranteed Delivery had been delivered for 847,858 Shares, representing approximately 1.5 percent of the currently issued and outstanding Shares. The press release announcing the extension of the Offer, issued by Dassault Systèmes SA on March 14, 2014, is attached as Exhibit (a)(5)(T) hereto, and it is incorporated herein by reference.”

Item 11. Additional Information.

Item 11 of the Schedule TO is hereby amended and supplemented by adding the following text thereto:

“On March 13, 2014, the applicable waiting period in Austria expired without action from the Austrian merger control authority Bundeswettbewerbsbehörde with respect to the transactions contemplated by the Merger Agreement. Accordingly, the condition of the Offer relating to applicable waiting periods under applicable antitrust laws in Austria having expired or been terminated and to all applicable consents or approvals required under any other applicable antitrust laws in Austria having been obtained has been satisfied.”
