Unilever NV announces that on 27 September 2007 it purchased 367,172 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.000 and euro 22.220 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 7,296 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 95,849,681 Unilever NV ordinary shares in treasury, and has 1,618,878,019 Unilever NV ordinary shares in issue (excluding treasury shares).
