Reimert and Reimert Family Partners, Ltd., (ii) Gary D. Smith and Four Smith s Company, Ltd. and (iii) J. Mike Walker. The parties to the Stockholders Agreement may be deemed to have formed a group pursuant to Rule 13d-5(b)(1) promulgated under the Securities Exchange Act of 1934, as amended (the Exchange Act). Any such group could be deemed to have beneficial ownership, for purposes of Section 13(d) and 13(g) of the Exchange Act, of all equity securities of the Issuer beneficially owned by such parties. Such parties would, as of January 31, 2004, be deemed to beneficially own an aggregate of 10,575,542 shares of Common Stock, or approximately 59% of the total number of shares reported to be outstanding in the Issuer s Form 10-Q for the quarter ended September 30, 2003. Mr. Walker disclaims the beneficial ownership of any Common Stock owned by such other parties, except to the extent he may be deemed beneficial owner of such common stock for purposes of Section 13(d) and 13(g) as described above.
