In February 2005, the Company completed its initial public offering and in March 2005 it completed a \$1.6 billion securitization transaction. Management has devoted significant time and effort to completing these transactions. As a result of the timing of these transactions and the resulting changes in the Company's business strategy (it now operates as a real estate investment trust) management is unable to complete the preparation of its financial statements and annual report on Form 10-K to facilitate the completion of the annual audit and review of the Form 10-K by its auditors by March 31, 2005 without unreasonable effort or expense.
