**Item 7.01 Regulation FD Disclosure.**

On December 1, 2005, Salomon Brothers Global High Income Fund Inc. (the Fund ) issued a press release stating that the new investment management contract between the Fund and its investment adviser and the new sub-advisory contract, which had been previously approved by the Fund's shareholders, have become effective as a result of the closing of the sale of substantially all of Citigroup Inc.'s asset management business to Legg Mason, Inc.
