In determining annual cash bonus incentives for the Company s executive officers, the Compensation Committee considers the achievements of each executive officer relative to his or her individual goals and objectives for the year, as well as the Company s achievement of its goals and objectives for the year. The Compensation Committee bases its decisions on a number of factors, including the Company s financial performance, the achievement of certain strategic goals and each executive s contribution to the Company s overall performance. If the Company exceeds its goals and/or the executive exceeds his or her goals, the annual cash bonus incentive could be subject to increase under certain circumstances at the discretion of the Compensation Committee, of up to 200% of the bonus target.
