Item 8.01 Other Events.

As previously reported, in July 2013, Northwest Natural Gas Company (NW Natural) filed with the Public Utility Commission of Oregon (Commission) a stipulated settlement with all parties which, if approved by the Commission, would resolve outstanding issues from the 2012 Oregon general rate case in the docket dealing with NW Natural s new Site Remediation and Recovery Mechanism (SRRM). The settlement was subject to the review and approval of the Commission.

On November 18, 2013, in a 2 to 1 decision, the Commission issued an order rejecting the settlement and ordering further proceedings. The two commissioners signing the order stated their belief that the disallowance of \$7 million from recovery of incurred costs through the proposed SRRM was too low and that the environmental remediation costs at issue raise public policy considerations about how the Commission should address the sharing of costs, earnings reviews and other proposals made by the parties to apportion costs fairly. The two commissioners signing the order stated their belief that these issues should not be resolved through a stipulation, but rather through a more thorough examination of the facts and policy standpoints. The remaining commissioner dissented from the order. The order provided that the Commission will schedule a prehearing conference to adopt a schedule for further proceedings in the docket.
